Why Welfare Depends on Fairness Michael B. This paper argues that Kaplow and Shavell's goal of eliminating non-economic discourse from policy debates is not achievable. Because the choice of a social welfare function rests on philosophical fairness justifications and because this choice also determines the policy recommendations produced by welfare economics I argue that fairness theories are inevitably at the heart of economic analysis. It is therefore impossible to separate the fairness debate from policy analysis and to apply welfare analysis exclusively.
